**Item 4. Ownership.**

- (a) Amount Beneficially Owned: As of December 31, 2017 NEA 14 is the record owner of Common Stock and Class B common stock ("Class B Common Stock") as described below. As described in the Issuer's 10-Q, filed with the Securities and Exchange Commission on December 15, 2017 (the "10-Q"), holders of Class B Common Stock are entitled to ten votes per share while holders of the Common Stock are entitled to one vote per share. In addition, holders of Class B Common Stock and holders of Common Stock generally vote together as a single class.
